

DomeMUN — Terms and Conditions/Rules of conduct

By registering for DomeMUN ("the Conference"), participants (or, where applicable, their parent/guardian or supervising MUN director/school) agree to the following terms and conditions.

1. Registration

1.1 Registration is completed via the official DomeMUN registration forms (School delegation, Single delegates, Student Officers, or Hageveld Students), available at domemun.nl/registration.

1.2 Registration deadlines:

Registration deadlines are to be set by the organizers of DomeMUN. They are not to be changed a month before set date.

1.3 A registration is only confirmed once the organizing team has accepted the application and the applicable fee has been received.

2. Fees

2.1 Fees are as follows:

All fees are to be set by the organization of DomeMUN. They are not to be changed without informing all applicant. They are not to be changed 3 months before the set registration deadlines

2.2 Fees cover participation in the Conference, including committee sessions and materials provided by the organizers. Fees do not cover travel, accommodation, or meals unless explicitly stated otherwise.

2.3 Payment instructions will be communicated after registration is submitted.

3. Cancellation and Refunds

3.1 Free cancellation

Free cancellation is possible up to the date set by the organization of DomeMUN.

3.2 Cancellations made after these deadlines are not eligible for a refund, as the organizers will have already committed to costs (materials, catering, venue arrangements) based on confirmed numbers.

3.3 Cancellations must be submitted in writing to domemun@hageveld.nl.

3.4 The organizers reserve the right to reassign a cancelled delegate's country or position to another applicant.

4. Changes to the Conference

4.1 The organizers reserve the right to change the programme, committee list, dates, venue, or fees if circumstances require it. Registered participants will be informed of any material changes as soon as possible via domemun.nl or direct email.

4.2 In the event DomeMUN is cancelled by the organizers, registered participants will be offered a full refund of fees paid.

5. Conduct

5.1 All participants are expected to behave respectfully towards fellow delegates, Student Officers, MUN-directors, guests, staff, and venue personnel at all times.

5.2 Participants are expected to follow the Rules of Procedure as communicated by the Chairs of their committee, including any crisis mechanism specific to their committee.

5.3 The organizers may, at their discretion, remove a participant from the Conference without refund in cases of serious misconduct, harassment, or repeated disruption of proceedings.

5.4 Hageveld's school rules and Dutch law apply throughout the Conference, in addition to these terms.

6. Committee Format and Crisis Mechanism

6.1 Non-GA committees (HRC, SC, ECOSOC) feature a crisis format: only one of two topics is published in advance. The second topic ("the crisis") is introduced at an undisclosed time during the Conference and takes priority over the topic under debate at that moment.

6.2 Delegates are expected to prepare using the research reports provided by their committee's Chairs ahead of the Conference.

7. Liability

7.1 Participation in DomeMUN is at the participant's own risk. The organizers, Atheneum College Hageveld, and its staff and Student Officers are not liable for personal injury, loss, or damage to property during the Conference, except in cases of gross negligence or intent on the part of the organizers.

7.2 Participants (or their school/parent/guardian) are responsible for arranging their own travel to and from the venue, and any related insurance.

8. Media and Photography

8.1 Photos and/or video may be taken during the Conference for use on DomeMUN's website and social media channels (Instagram, TikTok). By participating, attendees consent to this unless they notify the organizers in writing in advance.

9. Privacy

9.1 Personal data submitted during registration is processed in accordance with DomeMUN's Privacy Statement, available at domemun.nl.

10. Governing Law

10.1 These terms and conditions are governed by Dutch law. Any disputes will first be addressed directly with the organizing team via domemun@hageveld.nl.
